



## Czech Republic new energy storage subsidies

What is the current energy policy in the Czech Republic?The government is in the process of revising the country's energy policy and legal frameworks. The "State Energy Policy" (SEP) is the main strategic document guiding energy policy in the Czech Republic (MPO, ). The current SEP dates from May and contains an outlook to . Among those are subsidies for the retrofitting of existing coal-fired power (though those are no longer available) and co-generation plants to make them more efficient and extend their life cycle.
