What tariffs are imposed on Chinese solar cells & modules? The U.S. had imposed several trade barriers against Chinese solar cell and module imports. In addition to the original 25% tariff under the Section 301, there are anti-dumping and countervailing duties (AD/CVD) that have been imposed since as well as the Section 201 tariffs targeting cells and modules from all countries. Which solar companies do not incur import tariffs? Other "Domestic" Suppliers: A few manufacturers with U.S.-based production or assembly - such as Hanwha Qcells (Georgia factories), First Solar (Ohio), Mission Solar (Texas), and Silfab (Washington) - do not incur these import tariffs on their U.S.-made panels. They have an effective price advantage now. How will the 301 tariff affect the US solar supply chain? Notably, the adjusted 301 tariff expands to cover Chinese exports of polysilicon and mono-Si wafers, with a 50% tariff rate set to take effect on January 1, . In summary, as of April we see solar panel prices up by 20-40% (depending on origin), inverters up ~10-30%, and battery costs up significantly (~30% or more) compared to pre-tariff levels. These increases correlate directly with the reciprocal tariff rates imposed (34% on China, 36-49% on SE Asia, etc.), underlining the tariffs' impact. Will bifacial solar panels be exempt from tariffs? In his announcement, the President included an exemption for bifacial solar panels. This decision comes after the ITC recommended in November to extend the safeguard tariffs for an additional four years. Proclamations The countervailing and anti-dumping duties are in addition to existing section 201 solar tariffs that are currently 14%, but are scheduled to end on February 6, , and to "reciprocal" tariffs that took effect on April 5, at a 10% rate and are scheduled to increase to 46% for Vietnam, 24% for Malaysia, 36% for Thailand and 49% for Cambodia on July 9, .
